 - b. Sidewalk repair The Budget and Finance Committee reviewed bids for approximately 100 pieces of sidewalk slabs to be replaced on various streets. Ken Walsh made the motion that "The Budget and Finance Committee recommends the use of Brothers Paving at a cost of up to \$13,500 to replace approximately 100 sidewalk slabs on various streets." The motion was seconded by Alison Stern. The motion passed "Unanimously".
