- 3. Public Comment / Issues None
- 4. No one electronically recorded the meeting. Minutes were recorded for this meeting by Ty Kehrer.
- 5. 2023 Budget Review Kristi Felouzis guided the group through the proposed budget for 2023. Various changes were proposed by Budget and Finance members and the Board members. Frank Puleo made the motion that "The Budget and Finance Committee recommends passage of the 2023 Budget onto the Board of Directors for final approval." The motion was seconded by Ken Walsh. The motion passed "Unanimously".
- 6. Review and Adopt the Minutes from the July 27, 2022, Meeting:
  - a. Frank Puleo made a motion that, "The Budget and Finance Committee accepts the July minutes as presented." The motion was seconded by Ty Kehrer.

- 7. Review of Financial Statements:

- a. 606 Pathway The Budget and Finance Committee reviewed bids for the path replacement from Braddock Road to Panera Bread along Rt 606. Ken Walsh made the motion that "The Budget and Finance Committee recommends the use of Dominion Paving at a cost of up to \$120,000 from Replacement Reserves to replace the pathway along Rt 606 from Braddock Road to Panera Bread." The motion was seconded by Ty Kehrer. The motion passed "Unanimously".
- b. Elk Lick Park Basketball Court The Budget and Finance Committee reviewed bids for the basketball court to be repaired and upgraded at Elk Lick Park. Ken Walsh made the motion that "The Budget and Finance Committee recommends the use of Sport Court of

- Washington at a cost of up to \$100,000 from Replacement Reserve funds to repair and upgrade the basketball court at Elk Lick Park." The motion was seconded by Frank Puleo. The motion passed "Unanimously."
- c. Elk Lick Pickleball Court The Budget and Finance Committee reviewed bids for a new pickleball court to be built at Elk Lick Park. Frank Puleo made the motion that "The Budget and Finance Committee recommends the use of Sport Court of Washington at a cost of up to \$100,000 from build a new pickleball court from Capital Improvement funds at Elk Lick Park." The motion was seconded by Ty Kehrer. The motion passed "Unanimously."
